WIOA Core Partner Programs:

Ruthy Davis reported that, per the local plan, technical assistance would be given to board members regarding the WIOA core partners and their programs, building on the brief introduction partners given at the March 8, 2018 Board Orientation.

Five Core Partners:

- Title 1-Adults, Dislocated Workers, and Youth as well as the board
- Title II-Adult Education & Literacy
- Title III-Wagner Peyser
- Title IV-Rehabilitation Act Program
- TANF-included as a core partner due to appointment by the Governor

Title I-Adult, Dislocated Workers & Youth Programs - *Ruthy Davis*

Identified what those services include, who they support and where they can be found.

Success Stories:

o Hobby Lobby, Lexington Park, MD. Recruitment set up, over 600 individuals attended, store staffed from recruitment.

 Kelsey Z- single mother of 6-month-old, dreamt of working in the Healthcare Industry. We assisted her financially to obtain certifications, and she is now employed with St. Mary's Medstar Hospital.

Title II-Adult Education & Literacy Programs - *Eddie McGreevy*

Identified what Title II is, who they support, what services they provide and where the services are located. Services provided include GED preparation and testing, National External Diploma Program (NEDP), and English as a Second Language instruction.

Success Story:

Ben went through the NEDP, graduated at 65 years old, and is now enrolled at CSM in prelaw.

Provided statistics on those being served through ABE (Adult Basic Education) and ESL (English as a Second Language).

Title III: Wagner-Peyser Employment Services Programs – Meredith Alonso

Identified where they are located, what services they provide, who they support. Services include workshops, partnering with other programs, job search, resume building, referrals to businesses.

Success Story:

At a TCCSMD recruitment, a jobseeker was referred to the business. The business was happy with their skill set, and the individual was hired.

Title IV: Rehabilitation Act Program - Michelle Stewart

Identified their services, along with their service priorities, Pre-ETS eligibility, partnership training, working while retaining disability benefits, and their exit process & follow-up.

Category 3 - Non-severe disability

Success Story:

Consumer wanted CDL training. Obtained training and support by numerous partners and is now employed by VanGo.

TANF Training & Employment Programs - Toni Gorman

Provided and overview of what TANF is, identified the program's process, identified services including workshops and placement statistics.

Success Story:

Stacy is a non-custodial parent now employed at Safeway. Anna single parent, was placed in a volunteer capacity at Project Echo, was then offered the job as an employee making \$15 with Project Echo was then offered a position with DHS/Prince Frederick office as an Administrative Assistant.

Rodney Giles offered additional insight into the program and Toni's services. Spoke about an innovative Online training site: Common Ground.

Governor's Workforce Development Board - Ken Lemberg

Began with question & answer session along with an introduction and his career history. Provided insight into his current role on the Governor's Workforce Development Board as part of a staff of 4. Provided a success story on a product they are developing to allow job seekers to zoom in on local employers and their workforce requirements.
